10. If the Event Organizer fails to observe the conditions of the Contract Application (cancellation of the rent of premises), he is liable for a cancellation penalty equal to 20% of the Contract and/or the Application amount.

11. Issues not covered by the Contract shall be subject to the General Terms of Holding Events at Expocentre Fairgrounds approved by Expocentre General Director's Order No.98 dated 31.07.2013, that are integral part of the Contract and its Enclosures with further amendments. The EVENT ORGANIZER has read and accepted the General Terms of Holding Events at Expocentre Fairgrounds as well as Enclosure No.1 Rental Rates and Rates for Services for Organizers of Events at Expocentre Fairgrounds.

12. All disputes, differences or claims arising from this Contract or in connection with it, including its fulfillment, violation or invalidity, shall be subject to settlement in the International Commercial Arbitration Court with the Chamber of Commerce and Industry of the Russian Federation in accordance with its Statute. Decisions of the Court shall be final and binding for the Parties. Governing material law shall be Russian

13. The Contract may be executed and/or other documents may be exchanged by facsimile transmissions and electronic mail with mandatory dispatch of original hard copies of the e-mailed/faxed copies. The EVENT ORGANIZER undertakes to send EXPOCENTRE the originals of the executed Contract and other executed documents by personal delivery recorded delivery post within five days of the date of execution.
